NOTIFICATION

In exercise of the powers conferred by section 57 of the Rights of Persons with Disabilities Act, 2016 (Central Act 49 of 2016), read with Notification No.16-09/2014-DD-III dated 4/01/2018, issued by the Ministry of Social Justice and Empowerment (Department of Empowerment for Person with Disabilities), published in the Gazette of India, vide S.O.76 (E), in Part II-Section 3(ii), and in supersession of the Government Notification No.7/2/2004-III/PHD(MISC)/4066 dated 31/10/2018, No.7/2/2004-III/PHD(MISC) dated 28/08/2013, No.7/2/2004-III/PHD(MISC) dated 23/09/2013, No.13/140/87-I/PHD dated 01/02/1989, No.7/2/2004-III/PHD dated 4/2/2004, No.51-2-2006-07-HC/2312 dated 19/7/2007 and No.51-2-2006-07/HC/5008 dated 26/10/2006, the Government of Goa hereby designates the following certifying authorities for North Goa District namely:-

1. For Locomotor Disability:-

- (i) Medical Superintendent, North Goa District Hospital.
- (ii) Orthopedic Surgeon or *Specialist in physical medicine and rehabilitation, North Goa District Hospital.
- (iii) One Specialist as nominated by Medical Superintendent, North Goa District Hospital, as per the condition of the Person with Disability.

2. For Visual Impairment:-

- (i) One Ophthalmologist, North Goa District Hospital.
- (ii) Certificate of Disability shall be countersigned by Medical Superintendent or Any other equivalent authority, North Goa District Hospital, as noticed by the State Government.

3. a) For Hearing Impairment:

b) For Speech and language Disability:-

- (i) Medical Superintendent or any other equivalent authority, North Goa District Hospital, as notified by the State Government will be the Head of Certifying Authority.
- (ii) ENT specialist, North Goa District Hospital.
- (iii) One Specialist (**Audiologist/Speech Language Pathologist) , North Goa District Hospital.

4. For Disability caused due to blood disorder:-

- (i) Medical Superintendent, Chairperson, North Goa District Hospital.
- (ii) General Physician or Pediatric or Pediatrician, North Goa District Hospital.
- (iii) Orthopedic surgeon or *specialist in physical medicine and rehabilitation, North Goa District Hospital.
- (iv) In case specialties sequel relating to visual abnormality, hearing problem, cerebral dysfunction, respective specialist, North Goa District Hospital.

5. For Multiple Disabilities:-

- (i) The Medical Superintendent or any other equivalent authority, North Goa District Hospital, as notified by the State Government will be the Chairperson of Certifying Authority.
- (ii) Specialist, North Goa District Hospital, required for assessing the disabilities as per the requirement of respective guidelines.

6. a) For Intellectual Disability:-

- (i) Medical Superintendent or any other equivalent authority, North Goa District Hospital, as notified by the State Government will be the Head of Certifying Authority.
- (ii) Pediatrician or *pediatric Neurologist (where available) or physician (if age > 18 years), North Goa District Hospital.
- (iii) **Clinical or *Rehabilitation Psychologist, North Goa District Hospital.
- (iv) Psychiatrist, North Goa District Hospital.

b) For Specific Learning Disability :-

- (i) Medical Superintendent, North Goa District Hospital.
- (ii) Pediatrician or *Pediatric Neurologist (where available) or Physician (if age > 18 years), North Goa District Hospital.
- (iii) **Clinical or *Rehabilitation Psychologist, North Goa District Hospital.
- (iv) **Occupational Therapist or *Special Educator or Teacher Trained for Assessment of Specific Learning Disability, North Goa District Hospital.

7. For Mental Illness:-

- (i) The Medical Superintendent, North Goa District Hospital, shall be Head of the Certifying authority.
- (ii) Psychiatrist, North Goa District Hospital, for clinical assessment
- (iii) **Trained Psychologist, North Goa District Hospital, to administer IQ tests.

8. For Disability caused due to chronic neurological condition:-

- (i) The Medical Superintendent or any equivalent authority North Goa District Hospital, as notified by the state Government will be Head of Certifying Authority.
- (ii) Pediatrician, North Goa District Hospital, for childhood chronic neurological conditions/Psychiatrist for mental illness due to chronic neurological condition/**neurologist for chronic neurological conditions without mental.
- (iii) *Specialist for certifying Locomotor Disability/Orthopedic Surgeon, North Goa District Hospital.
- (iv) **Trained Psychologist (clinical or Rehabilitation), North Goa District Hospital, to administer IQ tests.


9. For Autism spectrum Disorder:-

- (i) **Clinical or *Rehabilitation Psychologist, North Goa District Hospital.
- (ii) Psychiatrist, North Goa District Hospital.
- (iii) Pediatrician/General Physician, North Goa District Hospital.



This notification shall come into force on the date of its publication in the Official Gazette.
